

**ORDINANCE NO. 5067**

**ORDINANCE AMENDING CHAPTER 2.120  
OF THE SANTA CRUZ COUNTY CODE REGARDING  
MEMBERSHIP, TERM OF OFFICE, AND  
ORGANIZATION AND PROCEDURE OF THE  
FIRE DEPARTMENT ADVISORY COMMISSION**

The Board of Supervisors of the County of Santa Cruz ordains as follows:

**SECTION I**

Section 2.120.020 of the Santa Cruz County Code is hereby amended to read as follows:

**2.120.020 Membership.**

- A. The commission shall consist of seven members, residents of the county, appointed by the board of supervisors.
- B. Each supervisor shall nominate one person who may reside within the supervisor's district. Each nominee shall also reside within the jurisdiction of the county fire department, except for the fourth district supervisor's nominee.
- C. The remaining two members shall be at-large appointments designated for nomination by the following county department/groups:
  - 1. Volunteer company officers organization;
  - 2. Office of emergency services.

**SECTION II**

Subsection B of Section 2.120.040 of the Santa Cruz County Code is hereby amended to read as follows:


- B. County staff. The county fire department shall provide staff support for the commission.


**SECTION III**

This ordinance shall take effect and be operative on the 31<sup>st</sup> day after the date of final passage.


